## 1121/18 Prison Report

Cllr Young confirmed he attended the HM Prison Usk & Prescoed Liaison Meeting.

Cllr Young noted both establishments are at full capacity with 270 inmates in Usk and 260 in Prescoed. Both Prisons were recently granted Level 4 status following a Prison Audit review.

Next year HM Prison Usk will celebrate its 175 anniversary.

Cllr Young was pleased to confirm the Carpentry Department at the Prison is now open again and accepting work/commissions. The Chairman confirmed he would bear this in mind for further work requirements across the wards.

## **Local Matters**

## 1125/18 Continued Unkempt/uncut verges and Hedgerow at Cwrt Farm Water Works

Chairman Waters confirmed the bollards at the reservoir lay-by remain broken, enabling access to the area. In addition, the verges and hedgerows have not been cut or tidied as promised by the Business Improvement Manager at the site in May 2018.

Clerk Thomas circulated a letter, escalating the matter to Mr Perry, Director of Water Operations for Cwrt Farm Water Works. The Chairman and Councillors approved the letter.

## 1126/18 Millennium Bench, Llanhennock

Cllr Young noted youths have had a fire at the above site – leaving embers, debris and litter. The Chairman confirmed this should be reported to PC Evans. However, Councillors agreed this was unlikely to prevent young people using the area for anti-social behaviour. Matter to be reviewed at the next meeting.
